Dear Honorable Judge Dawn Nichols,

I have taken the liberty of listing all three case numbers, as they are intricately interconnected. The following report clearly identifies corruption and police brutality, working in conjunction with officials in Volusia County, Florida, guilty of abuse of power. Leaving my current legal representation, Mr. Kevin Pitts with the inability to effectively advocate or defend my position, repeatedly making concerted effort to disregard my well-documented allegations for fear of incriminating himself, mainly by ignoring. In my quest for truth in the desperate pursuit of justice, I feel it is incumbent upon myself to address the court directly, owing to the esteemed authority and respect that your position commands. Only through truth can real growth be attained absent of preconceived notions or mental projections caused by cultural bias and social influence. This report will be included in a 15-page complaint that will be submitted to the Department Of Ethics, today April 20, 2023.

On September 15 2021, a letter addressed by the Clerk of Court, sent to my residence claiming I owed \$323 on case 2011 002740 CFAWS. I immediately wrote the judge, explaining I had satisfied all financial obligations, perusal the amendment page at [www.clerk.org](http://www.clerk.org) confirms the payment was made on March 21, 2012. Volusia recorded an unlawful judgment the very next day, March 22, 2012. In January 2022, when I was forced to re-pay this a second time. Over \$550 with fees, Volusia only applied \$10 to this case and an additional \$28 to two other cases. Case 2011 002563 CFAWS, paid on the 21st recorded another unlawful judgment on March 22, 2012. Case number 2011 02567 CFAWS, was paid on October 18, 2012. Volusia recorded yet another unlawful judgment in my name, six days later on October 24, 2012. This is a common practice for Volusia County who has an explicit amount of judgments that they simply have not yet tried to collect.

I have reported this to multiple government organizations, including but not limited to the FBI, Internal Affairs, (DOJ) Civil Rights Department, Florida Attorney General, the Federal Attorney General and Office Of Governor Ron DeSantis. *My 3rd complaint submitted to Internal Affairs approximately 2 weeks prior to 02/21/2023 is 27 pages, containing photo copies of the fraudulent activity littered all over the Volusia County Courts website at [www.clerk.org](http://www.clerk.org)*

On October 13, 2021 while experiencing severe harassment, after my drivers license was unlawfully suspended, through the manipulation of court recorded documents. My daughter and I were unlawfully stalked, assaulted, and victimized by *Deputy Meshelle Naylor who committed a litany of crimes so deplorable, they will one day serve as excellent training material on what a police officer should never do!* Operating under the direct supervision of her superior officer, Sergeant Jason Stickles.

**PLEASE NOTE:** Officer Naylor, a Deputy not in her normal car, but in an undercover unmarked vehicle, causing confusion among the hit-squad Sergeant Stickles supervised! Anyhow, Deputy Naylor working under the guise of an unlawful B.O.L.O camped out on a back road, at school release time, 1 mile from my residence where I have lived for the better part of 35 years, exactly 1.6 miles from the police station, where both of these corrupted police officers are employed! Naylor, contradicting, and fabricating an almost laughable amount of statements, on state recorded evidence. *All of which can be viewed on my*

YouTube channel @DEVINE-GRIND. Quite literally, the entire case crumbles in the first two sentences of the discovery. Naylor purports she conducted a routine check of my license plate, and upon discovering that it was suspended, decided to initiate the stop. All lies! Naylor operating under an unlawful "be on the lookout" (BOLO) order, and the sole reason for her unwarranted intrusion into my home, to unlawfully coerce evidence at the behest of her commanding officer. Why is it that none of my three legal teams were able to provide me with any of this information and I had to find it on my own? Moreover, she goes on to elaborate on how I fled the scene and "that's why the guns were drawn." Pathetic as Naylor not even a good actor fails to furnish any evidence in support of her fabrications. Any person remotely related to do with this case, should be ashamed of them self.

*With the utmost respect Your Honor, I trust you are cognizant of my competence, despite summoning me to court on February 21, 2023, to determine competency. Only 2 weeks after my 3rd comprehensive complaint submitted to the Office of Internal Affairs, outlining the unmistakable corruption between the courthouse and (Purdue, Brenden, Felder, Collins, and Mott, LLP.) Regrettably this renders it impossible for me to receive a fair trial in Volusia County and the main reason local law enforcement has persistently trampled upon my civil rights. At this point it is now well understood my court records were manipulated, clearing old judgments that were fraudulent to begin with! I respect your position and authority, but Your Honor to bring me in to determine competency on February 21, 2023 calling me delusional repeatedly prior to asking Mr. Pitts if my delusions were preventing him from representing me properly. Then finally ruling me competent only for NOW! I feel these comments clearly indicate you are not impartial in this case, as a judge is supposed to be in the search for truth, in the name of justice.*

On April 5, 2023, after realizing the state never intended on going to trial, I inadvertently failed to appear for docket sounding. Less than 15 hours later local law-enforcement kicked my front door in and I was charged with resisting arrest without violence, 35 feet into my own home. I'm sure you understand the unlawful nature of this action because the local police department did not have a warrant for my home, only for my arrest. After 8 days of incarceration, in Court April 13, 2023 for a bond hearing while experiencing detoxification symptoms from my subscription medication Suboxone. When asked if I was being coerced into the plea deal of felony probation, I replied, no. *Shortly after realizing this was absolutely coercion. I was coerced into taking the deal of felony probation. It was made abundantly clear, if I needed to go home and care for my children, I needed to accept felony probation because bond was going to be denied!* Careful scrutiny of the court transcripts will validate these claims.

*Case #: FL 2022 102904 CFDL the warrant for "Scheme to Defraud" was issued December 27, 2022, exactly 20 days after I began feverishly speaking out about the corruption taking place in Volusia. I was arrested at the FBI on Keller Rd. January 4, 2023 at approximately 10:45AM, for an organization closed 3 years prior. The arresting officer took me into custody based on fabricated claims made by Maitland police detective Quinn. While unlawfully tracking my location, Quinn alleged that I was attempting to turn myself in at the FBI, MORE LIES!!! My claims can easily be substantiated with review of the police report documenting my arrest. In reality, I was actually reporting the corruption in Volusia, to the FBI which can be identified with FBI #59777. The state has three complaints out of 3500+ clients, and failed to mention the corporation responsible for the majority of revenue, on the information filed. If I was able to get a fair trial in Volusia it will be seen for exactly*

## **what it was, A SCHEME TO DISSEMINATE SAFETY INFORMATION!!**

At my September court appearance, the assistant state attorney speaking directly to yourself, claimed he was in possession of video evidence of me committing the crime of fleeing. This was a complete fabrication and outright fallacy, IN OPEN COURT UNDER-OATH! On December 7, 2022 after being forced to attend docket sounding without legal representation, the assistant state attorney recommended a competency evaluation, subsequently ordered by yourself. Then he so clearly exemplified. "I have reviewed the facts of this case thoroughly." I feel these words are invaluable and speak to something much much greater going on.

February 2023 while cited for a minor traffic violation I turned on my video recording device to protect myself from any further police brutality! I accidentally caught the brutality effects suffered by my child, who is now scared to even go to the grocery store. On March 16, 2023, I delivered a letter advocating for the release of a Izzy Acevedo who had been detained for the theft of my motorcycle. Upon Mr. Acevedo's release, he was served a restraining order on myself. I rhetorically ask, WHY? On March 19, 2023, a disgraceful turn of events transpired. Mr. Acevedo, a Good Samaritan, retrieved my stolen motorcycle, kindly delivered it to my residence and subsequently alerted the authorities to withdraw the "be on the lookout" order. Astonishingly, local law enforcement, made a blatant attempt to apprehend me on my property. Despite my repeated calls to "911" for assistance, the officers persisted with their unjustified and unwarranted efforts. My innocent daughter was traumatized, weeping inconsolably throughout the 60. I deliberately declined to engage with the police officers, who I knew had ulterior motives and were intent on framing me with fabricated charges. Consequently, the DeBary Police Department impounded my motorcycle, unlawfully confiscating it from my premises, as I refused to comply with their underhanded tactics. Acevedo was placed under arrest for Dealing In Stolen Property, and currently serving a sentence at the Volusia County Branch Jail.

Your Honor, I previously corresponded with you in December 2022 and quickly realized that the assistant state attorney leverages any information received to their best advantage. In that document, I shared my spiritual background, including a transcendental kundalini awakening experienced 10 years prior. There is a saying. "Many are called but few are chosen!" This matter is not merely one of legal consequence, but it strikes at the very core of our moral sensibilities, clearly identifying a deeply fractured system.

Theorizing about the circumstances surrounding the injustice that my family has unlawfully been subjected to. Such as my ex wife's husband's family who has many contacts with Volusia County law enforcement, seems truly futile at this juncture, as it is empirical evidence that holds relevance.

*As a humble single father who seeks the truth in the pursuit of justice, I am compelled to fight this, which I am convinced is critical to the evolution of our justice system.* With your busy schedule and your personal commitments, I am cognizant that you may not have been fully apprised of all the pertinent information concerning my case. Then forced to agree to felony probation in order to care for my children! Would you appreciate somebody doing that to your children Ms. Nichols? In my opinion, there is no compelling reason why I should not be able to do so in the comfort of my home with my children, who need my care. Let it be known, that I hold the highest regard for the judicial system and your esteemed position.

This will pull up a section of the website that almost looks as if it is not part of the site. At the top of the page enter Last name, first name, middle initial & erase the document # and click (search) This will bring up all recorded judgments. *This is how I found all three of my fraudulently recorded judgments that allowed the unlawful suspension of my drivers license 10 years later! Volusia records it as a judgment, but in its place, they put the original order of the fine levied by the courthouse. It's actually quite tricky & difficult for the untrained eye or somebody outside of the judicial system to pick up on.*



When I hired my attorney Kevin Pitts, he received a list of 947 participating organizations, most of which have tracking numbers. Contained in the following attachments, I have provided a small example of the effort put in, back in 2015. Take note of the dates on the letters: July 30, 2015 for the letter to schools, and August 20, 2015 for the letter to Debary Elementary. 


