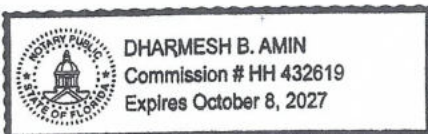

The respondent, Michael J. Chitwood, is heavily entangled, in the highest level of corruption, violating the ethics laws of the State of Florida in a variety of ways, necessitating the services of a virtuous investigator capable of representing this honorable commission with the utmost integrity.

### **STATE OF FLORIDA ETHICAL VIOLATIONS COMMITTED**

1. Ignoring financial crimes committed through the Volusia County Clerk's Office while attempting to intimidate and continuing to investigate the victims of those crimes.
2. Ignoring repeated civil rights violations by multiple police officers under his command while refusing to answer any questions about officers involved with outrageous cash real estate purchases.
3. Infringing upon the rights of minors by utilizing public arrests as a publicity stunt during the recent election.
4. Unethically used his position of power to cover up the faked suicide of Desire' Faith Drake on August 27, 2018.
5. The respondent is suffering from cocaine addiction.

### **BRIEF EXPLANATION OF EACH VIOLATION**

1. **Ignoring financial crimes executed through the Clerk's Office that that will become one of the largest RICO cases in American history.**

After I was forced back to the United States to address a fabricated felony case. I found myself genuinely concerned about the safety of myself and my family. Despite sending approximately 15 emails to the respondent, all correspondence was ignored. As a result, I submitted my first and second official complaints to the office of Michael Chitwood on November 8, 2022, and November 15, 2022, respectively. In these complaints, I thoroughly



articulated my experiences with gang-stalking and constant harassment. At that time, I expressed my concern regarding the suspension of my Driver's License, caused by a 2011 case. While I did have a case in 2011, I was on probation and paid all fines and fees associated with it. Furthermore, the Volusia County Courthouse consistently reported the status of all financial obligations as current for the previous 10 years. Despite these clarifications, the Office of Michael Chitwood found no wrongdoing. In turn, I launched a rigorous investigation of my own and on February 3, 2023, submitted a 27-page complaint with photos, exposing a troubling repetitive pattern of fraud and financial crimes facilitated through the Clerk's Office by a collection agency, established in 1970 out of Harris County, Texas, owned by a group of attorneys. The Office of Michael Chitwood again found no wrongdoing.

**2. Ignoring civil rights violations by police officers who purchased nearly 1.4 million worth of real estate in cash, the third-quarter of 2022, hundreds of thousands of dollars over appraisal.**

Just 17 days after submitting my complaint on February 3rd, exposing obvious financial crimes. I traveled to the Volusia County Sheriff's Office on February 20, 2023, to submit my fourth, incredibly detailed 16-page complaint exposing the entire conspiracy. On page one I wrote, speaking directly to the respondent.

*"Sheriff Chitwood, with all the evidence I've provided I know you can see this for it's true nature. The emotional torment I've had to endure is unfathomable! I've collected myself and I pray for your help!!"*

Upon delivery of the complaint, totally by chance, I encountered Sheriff Chitwood outside of his office, where he put forth his best effort to intimidate me. A week later the Office of Michael Chitwood again found no wrongdoing. On February 23, 2023, I submitted a fifth

complaint ensuring to address any points I may have overlooked in the previous four complaints. Approximately two weeks later, in the early morning hours of April 6, 2023, just 15 hours after a conjured Failure to Appear (FTA) on two completely fabricated cases with zero evidence, Deputies Igo and King weaseled their way onto my 1.5-acre lot on a school night. They disabled a gate nearly 100ft of the road, pounded on doors, and ultimately kicked in my front door, assaulting me at gun point, without a warrant for my home or property. Later that month I traveled to the Volusia County Sheriff's office to submit what would have been my sixth complaint and I was denied my civil right to do so. I filed a federal lawsuit against the Office of Michael Chitwood on October 11, 2023. **Two months later December 12, 2023, I traveled to the Volusia County Sheriff's Office to deliver the proverbial "nail in the coffin", a detailed 67-page complaint, containing mainly photos, completely exposing the fraud littered all over clerk.org in such a manner a 3rd grader who rides the short bus could understand it.** For the first time, the Office of Michael Chitwood did NOT claim no wrongdoing and finally acknowledged my well-documented allegations, delaying the criminal investigation upon completion of my civil case.

I understand it is not this commissions practice to visit any URLs. I am only mentioning mine because it is important to note that I created VolusiaCorrupt.com in preparation for mediation FL MID District Case 6:23-CV-01963-JSS-DCI. The website contains.

- a. All 8 official complaints submitted to the Office of Michael Chitwood.
- b. Irrefutable documentary evidence highlighting over 70 cases of financial crimes executed through the Volusia County Clerk's Office with a very detailed description on exactly how the fraud scandal operates.

- c. Rock-solid video evidence of civil rights violations committed by multiple (VSO) officers, none of which have been reprimanded.

In early November 2024, less than two weeks after the creation of my website, I learned VolusiaCorrupt.com was blocked from both Facebook and FDLE servers. Considering the aggressiveness of verbiage. I cloned the site under the domain VolusiaTruth.com containing all the same information utilizing much more user-friendly adjectives. **A week ago, I learned both domains are now blocked from FDLE servers while only VolusiaCorrupt.com is accessible by the Governor 's office.** (*What is going on here is highly illegal*)

### **3. Infringing upon the rights of minors by utilizing public arrests as a publicity stunt during the recent election.**

On September 13, 2024, while his opponent James Powers was gaining traction to become the next Volusia County Sheriff. Mike Chitwood held a public press conference sending a powerful message to parents.

*"Parents, if you don't wanna raise your kids, I'm gonna start raising them," he said. "Every time we make an arrest, your kid's photo is going to be put out there and if I could do it, I'm going to perp walk your kid so that everybody can see what your kid's up to."*

The following week, 11-year-old Honor Roll Student Carlo Kingston was publicly arrested based on the claims of 13-year-old Salvador Orta-Gleringer, who turned out to be a liar and has since been arrested for falsifying a police report. The family later learned that this transpired because (VSO) deputies visited Creekside Middle School the week prior, offering multiple children rewards for information about any other student allegedly threatening to shoot up the school. I have been in direct contact with Jessica Vance Louise, the guardian of



young Carlo Kingston who is now suffering from Complex PTSD because of the unlawful antics of the respondent. Ms. Louise is in the process of pursuing legal action against Michael Chitwood for violating her child's rights by publicly arresting Carlo without any valid evidence whatsoever, deputies only confiscated airsoft toys. As identified in the police report included herein. This was a well-orchestrated publicity stunt at the expense of a child! All of this could have and should have been avoided!

**4. Unethically he used his position of power to cover up a faked suicide.**

- a. She put her car in her mother's name the week prior.
- b. She prophesies her own death the night before.
- c. I was not allowed to attend the funeral, police orders.
- d. Enough blood in the house to kill multiple people.
- e. The funeral was closed casket no-one ever saw the body.
- f. After giving the police authorization to search they just left unannounced.
- g. The police report only indicated 1 gunshot, but the neighbor & security guard reported 2 gunshots.
- h. Never could get the supposed murder weapon returned, multiple attempts were repeatedly denied by (VSO) officers. According to the law, it should've been returned.
- i. The autopsy report had a few inconsistencies, recording multiple lacerations to the left expenditure, but there was only one, I witnessed it!
- j. She claimed she was part of a Motorcycle Gang & there was no getting out EVER!
- k. Contacted me about 10 times from different online profiles, each time using the slang term Alaye'.



Let's not forget that Desire' Faith Drake was only 21 years old at the time and highly susceptible to influence. Despite the age difference, Desire' and I share a deep bond with significant astrological signatures in our natal charts. Some might use the terms "soulmate" or "twin flame," but ultimately, at the end of the day it's math and the two of us have that in spades. I won't turn this into an astrology lesson, but I want to emphasize that this woman is alive! Her death was faked, and it was covered up by the respondent.

**5. The respondent is clearly still suffering from cocaine addiction.**

I've lived in Volusia for 38 years, and although most long-time residents will never say it publicly, Michael J. Chitwood's cocaine addiction has been well known within the community for a very long time. Back when he was chief in Daytona, there were times when I was in places I shouldn't have been, and I was asked to leave because "Chitwood" was coming through. This happened on more than one occasion. Based on his actions and appearance, the respondent is clearly still suffering from the same affliction.

**HOW I BECAME AWARE OF THESE FACTS**

Ironically, these events were triggered by the extreme narcissistic tendencies of my father, Richard Macker, who was unfortunately abused as a young boy by a priest and was never able to overcome that trauma. When he inherited far more money and power than he was prepared to handle, the result was a poor attempt to use his wealth, power, and influence to maintain control over our family. My now 73-year-old Italian father, who has significant ties to organized crime, inherited approximately \$30-\$40 million worth of real estate in 2015 and is a highly sophisticated career criminal who has mastered the art of playing the victim. In numerology, Richard's Birth Card is the 8 of Clubs, "The Card of Mental Force." Even at

his advanced age, he remains incredibly sharp and should not be underestimated. Richard killed my grandfather, Alex Frankel, by poisoning him in our home in 1997 and openly admitted this to me in 2010 after he assisted my mother during her passing, as she was very ill. Richard is a staunch bigot, and my grandfather Alex was Jewish. Fast forward to 2022: after learning that I had been placed on a terrorist list through falsified Homeland Security reports, I began aggressively speaking out on social media about the crimes committed against me, including falsified criminal charges initiated by corrupt officers. In response, Richard attempted to have me killed. I was poisoned during the first week of January 2022 and remained on the phone with a 911 operator in the early morning hours of May 26, 2022, terrified for my life because a hitman was trying to kill me. That same year, after my allegations were repeatedly dismissed, I launched my own rigorous investigation. In the last week of December 2022, I stumbled upon a paper trail of fraud that will eventually become one of the largest RICO cases in the history of the United States. I negligently shared my findings with my father. One week later, after fighting a false fleeing charge for over a year and refusing to take a plea deal, I insisted on going to trial. On January 4, 2023, I traveled to the FBI field office in Maitland to report the fraud I found all over the Clerk's website. I was arrested under the false pretense that I had gone to the FBI to turn myself in for a "scheme to defraud" related to a company I had closed three years prior, which had publicly advocated for child safety. I was completely unaware of the outstanding warrant.

I never cared about my father's money. In my 20s, I was able to generate more revenue in one year than my father did in his best ten years. For a narcissist with a terrible habit of needing to control everything in his environment, this was not an easy pill to swallow. I refused to bow down to him on financial, emotional, or psychological levels. He sought praise



in a deeply narcissistic and underhanded way, using his criminal affiliations to try to teach me a lesson. When I refused to submit and began expressing my voice on social media, it was determined that I needed to be removed from the situation permanently. Ultimately, I was deprived of my right to due process, which is why this case is now in federal court. All of this was covered up by the respondent, who had no intention of allowing me to survive to submit this report. Fortunately, the respondent is not the sharpest tool in the shed, making it relatively easy to see through his actions. Not only should Michael J. Chitwood be thoroughly investigated, but he should also be charged and booked for conspiracy to commit murder!

### CONCLUSION

Please keep in mind that we are discussing the highest level of corruption involving both the FBI and the CIA. The FBI initiated COINTELPRO—short for Counterintelligence Program—in 1956 to disrupt the activities of the Communist Party of the United States. In the 1960s, this program was expanded to include several other domestic groups, such as the Ku Klux Klan, the Socialist Workers Party, and the Black Panther Party. While they claim that all COINTELPRO operations ended in 1971, the program was re-initiated after September 11, 2001. Due to the respondent's repeated ethical violations in the state of Florida, I have become a target of this program in the country that I love so much. The Clerk is able to enter any amount of their choosing. Usually between \$10 - \$18 because it's the 2nd time collecting on the same fine. This is also the reason when the "double payment" is extorted, the amount reflected on the "amendment page" will NEVER equal the amount of the fine satisfied! The original payment is usually a perfect match...

Detectives reviewed the messages and observed Jakson (later identified as Jakson Delain (W2), Salvador (later identified as Salvador Orta-Gieringer (W3) and Erynn (later identified as Erynn Miller (W4) to be sending messages in reference to Carlo having shown them multiple guns / knives, and making a kill list and threatening to shoot students.

61. specifically said he was going to shoot up Silver Sands Middle School. He added that Carlo had written  
62. down a list of names on a notepad and specifically told them that it was a list of people he wanted  
63. to kill. Erynn was able to provide a list of the names she believed were written down by Carlo (Olivia  
64. / Olivia's sister / school bus / Kia / Nia / Gabby). Erynn advised no one else in the FaceTime video  
65. call made any threats. Erynn and Benjamin allowed detectives to look in Erynn's phone and no additional  
66. threatening messages were observed.  
67.  
68. Detectives then responded to 552 Hamlet drive, Port Orange, and made contact with Jessica Luise  
69. (P1). Jessica, the mother of Carlo Dorelli, was apprised of the above information. Jessica then reviewed  
70. an agency form regarding voluntary consent to search and gave both verbal and written consent for detectives  
71. to search within Carlo's respective room for any evidence. During the search, Detective Goggin located  
72. a notepad, containing a list of the following names: (Olivia / her sister / the bus / the remaining  
73. names were not legible). The notepad appeared to have stab marks in the paper. This list was written  
74. in what appeared to be black marker, which was consistent with the information obtained from the other  
75. juvenile witnesses. Additionally, the names on the list were also consistent with the information obtained  
76. from the other juveniles. Throughout Carlo's bedroom, detectives located various airsoft style rifles  
77. and pistols, magazines, fake ammunition designed to give a realistic appearance and several knives  
78. and swords. Additional information regarding the knives, swords, and airsoft rifles will be documented  
79. in a supplemental report. All evidence was stored in the VSO Crime Scene locker and was later transferred  
80. to VSO evidence.  
81.  
82. Following this search, Detectives Goggin and St John conducted an interview with Carlo and Jessica.  
83. Detective St John read Carlo his juvenile constitutional rights, from an agency issued Miranda rights  
84. card, and both Carlo and Jessica advised they understood those rights as they were read. Carlo then  
85. provided the following information:  
86.  
87. Carlo recalled being present in a facetime call with several of the other juveniles, to include  
88. Salvatore and Erynn. During this facetime call, Carlo decided he would show the other juveniles his  
89. collection of airsoft rifles and some of his knives. Carlo could not recall if he told the others the  
90. airsoft rifles were not real, functioning firearms. After showing off his airsoft rifles and knives,  
91. the other juveniles began to discuss how Carlo was going to complete a shooting at Creekside Middle  
92. School or Silver Sands Middle School. Carlo admittedly "joked" about these comments, but denied making  
93. any direct threat to either school. Carlo then denied ever creating/writing a list with other student's  
94. names, before recanting his statement and confessing to creating this list of names. Carlo added the  
95. names were written by him, but he had no intention of causing any of the listed individuals harm. Carlo  
96. advised the other juveniles on the facetime call told him to write the list of names, but later clarified  
97. they only provided him two names to add to the list. Carlo confessed to verbally telling the others  
98. the list was a "hit list". This list was created, discussed, and shown to the others as a "joke". Carlo  
99. was then shown the list discovered within his bedroom, and confirmed it was the list created by him  
100. and discussed with the other juveniles on the facetime call. Carlo had no additional information to  
101. provide. Carlo showed he had a basic understanding of the difference between the truth and a lie by  
102. answering several examples. Carlo swore the information he provided to the detectives was truthful.  
103.  
104.  
105. Based on the above information, it was determined there was probable cause to arrest Carlo for  
106. the offense of written threats of mass shooting/terrorism acts. Carlo was subsequently taken into custody  
107. without incident.  
108.  
109. During the search incident to arrest, Carlo's cellphone was located on his person. Carlo and Jessica  
110. provided the respective password for the cellphone (0607) voluntarily to Detective St John. Jessica  
111. later reviewed and signed an agency consent to search form for the cellphone, providing the Volusia  
112. Sheriff's Office consent to complete a digital examination of its contents for any additional evidence  
113. related to the offense. The phone was turned over to the digital forensics unit. All interviews were recorded  
114. on Detective Goggin's BWC.  
115.
