

Double fined for a closed case / license suspended

Message

Hello, I want to say it's a relief to find others going through the same thing. I was charged in 2012. Paid all court fines, met my terms/conditions by 3/31/16. In 2020 I received a letter stating my license was revoked due to nonpayment of court fines. For each case, it stated I still owed approximately \$640 adding up to approximately \$2500. I've been on a monthly payment plan since for \$76. Last payment is due next month April 2025. I can only imagine what the interest has added up to in 5 years. If I missed a payment I received a notice stating my license will be suspended. These cases were paid off in their entirety in 2016. I kept the letter of termination of supervision, thank god, but I've still wondered where these fines came from and it's been monthly harassment/extortion to make payments or I can't pick my children up from school.

My hope is that you can help me investigate what happened here and if I've been defrauded under the pressure of Volusia county court system/dmv for 5 years. I don't even know where to start.

Thank you for your consideration and I hope to hear from you soon.

November 2023, I received a letter in the mail explaining I owed over \$1000 on a case I remember paying because it was one of the stipulations of my probation. Which was terminated approximately seven years ago Malinski. Anyhow, the letter explained that I needed to go up to the courthouse on the following Saturday to satisfy the obligation or to work out a payment plan to avoid the suspension of my driver's license. When I got up to the courthouse, there were hundreds of people and two women with laptops on a folding table set up outside of the courthouse with all of the doors locked. Just about everyone was complaining because we all thought it was BS that we had to pay the same fine for a second time. So many years later. This is the second time they got me a few years ago. They did the same thing on a case from early 2000s and they said I have another one coming. I don't know what's going on up here but whatever it is it can't be legal. But what are we supposed to do? I have to go to work every day. I can't afford to have my driver's license suspended. What I witnessed that Saturday afternoon was one of the craziest things I've ever seen in my life. Literally everybody was complaining, but the women didn't care they said pay up or your license will be suspended. They did mention if I could provide them with a receipt then I didn't have to pay, but everybody knows they make you pay with the money order. Nobody has a receipt so many years later.
