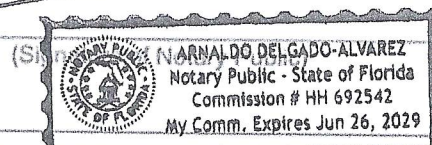

## **I. INTRODUCTION AND JURISDICTION**

This complaint is submitted to the Florida Commission on Ethics pursuant to **Article II, Section 8 of the Florida Constitution and Chapter 112, Florida Statutes**, which collectively establish that public office is a public trust and prohibit public officials from abusing their positions for improper purposes.

This complaint arises from Chief Deputy Brian Henderson's prolonged and unjustified delay of a criminal and internal affairs investigation for more than three years, and his recent assertion that the investigation will remain stalled until the conclusion of a separate civil matter currently pending in federal appellate proceedings. The actions described herein constitute abuse of official position, failure to perform official duties, obstruction of accountability mechanisms, and conflicts of interest, all of which fall squarely within the Commission's oversight authority.

## **II. BACKGROUND AND TIMELINE**

1. From November 8, 2022 - August 30, 2024, I submitted my first 8 complaints to the Volusia County Sheriff's Office Department of Internal Affairs. Consisting of 137 pages, documenting extensive criminal activity, misconduct, and corruption involving multiple state and private actors.
2. On August 13, 2025, I submitted a 131 page complaint to the Volusia County Sheriff's Office Department of Internal Affairs. Documenting further misconduct, containing irrefutable evidence of multiple state and federal violations.

3. On **December 2, 2025**, I submitted detailed information to the **Volusia County Sheriff's Office Department of Internal Affairs** documenting extensive criminal activity concerning Sergeant Jason Scott Stickels also known as Jason Alan Stickles who committed fraud by purchasing property with a known alias. "Jason Stickles."
4. Despite the seriousness and specificity of the allegations, **Chief Deputy Brian Henderson has delayed meaningful investigation for more than three years.**
5. Most recently, **Chief Deputy Henderson** asserted that the internal investigation will not proceed until the completion of my unrelated civil case, which is currently pending before the United States Court of Appeals for the Eleventh Circuit.
6. That appellate matter itself has been delayed due to my inability to pay filing costs, as I am seeking leave to proceed in forma pauperis, having become indigent as a result of the alleged criminal conduct at issue.

### **III. ALLEGATIONS OF MISCONDUCT**

#### ***a. Abuse of Official Position and Improper Delay***

Chief Deputy Brian Henderson has **used his official authority to indefinitely delay an internal and criminal investigation**, without legal justification, under the pretext of awaiting resolution of a separate civil matter.

There is **no lawful requirement** that an internal affairs or criminal investigation be suspended pending the outcome of a civil appeal,



particularly where the public interest and potential criminal exposure of officials are implicated.

This conduct constitutes:

- Abuse of official position
- Failure to perform required duties
- Obstruction of accountability and oversight

*b. Conflict of Interest and Self-Protection*

The delay appears **intentional and self-serving**, as Chief Deputy Henderson is alleged to be **personally implicated** in the underlying misconduct. By preventing investigation into allegations that may expose his own involvement or institutional failures, Chief Deputy Henderson has placed personal **and professional interests above the public trust**, in violation of ethical standards governing public officials.

*c. Fraudulent Court Reporting and Credit Damage*

After I was coerced into double paying a **10-year-old fine** in order to reinstate my driver's license, **Volusia County began reporting fraudulent judgments from unrelated cases** to my credit profile.

These actions occurred:

- Without proper notice
- Without lawful adjudication
- In violation of federal credit reporting and due process requirements

*d. Organized Criminal Conduct Involving Public Officials*

Evidence submitted to Internal Affairs demonstrates:

- Coordination between corrupt officials and private actors
- Fraudulent duplication of charges on decade-old cases
- False reporting to credit bureaus
- Retaliatory conduct after I spoke publicly about these matters

These actions are consistent with **high-level organized misconduct**, not isolated administrative error.

*e. Fraudulent Use of an Alias by a Law Enforcement Officer*

**Sergeant Jason Scott Stickels**, also known as **Jason Alan Stickles**, is alleged to have **purchased property using a known alias**.

A basic background check reveals that:

- “Jason Stickels” and “Jason Alan Stickles” are the same individual
- The alias was used in a manner inconsistent with lawful transparency

This conduct raises serious ethical and criminal concerns and warrants independent investigation.

*f. Retaliation and Selective Enforcement*

I was subjected to criminal charges for allegedly publicizing this law enforcement officer's address, while simultaneously being denied protection and investigation when I reported threats and attempts on my life. Selective enforcement and retaliatory charging undermine constitutional protections and demonstrate **bad-faith use of prosecutorial and law enforcement authority.**

#### **IV. HARM SUFFERED**

As a direct result of the misconduct described:

- My credit has been severely damaged
- I have lost financial stability and become indigent
- My access to the courts has been impaired
- My personal safety has been repeatedly threatened
- My constitutional rights have been compromised

#### **V. SPECIAL CONSIDERATIONS**

4. This involves very high-level organized crime blatantly violating all ethical standards.

## **VI. REQUEST FOR RELIEF**

I respectfully request that the Florida Commission on Ethics:

1. Open a **formal ethics investigation into Chief Deputy Brian Henderson**
2. Examine the improper delay and obstruction of internal investigations
3. Review conflicts of interest and misuse of authority
4. Refer any criminal findings to appropriate prosecutorial authorities
5. Take all actions necessary to restore public trust and accountability
6. Impose any appropriate sanctions or corrective measures authorized under Florida law

## **VII. CONCLUSION**

Public office is a public trust. When senior law enforcement officials use their authority to delay investigations, shield misconduct, or retaliate against whistleblowers, the integrity of the justice system is fundamentally compromised. This complaint is submitted in good faith, supported by documentation, timelines, and publicly verifiable evidence. I respectfully urge the Commission to act promptly and decisively.

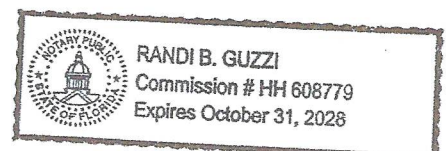

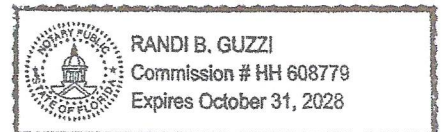
