

COMPLAINT DETAILS

5/1/25 - Sgt. Jason Stickles committed perjury all throughout his federal deposition. Claiming not to know Adam Macker or any of his associates. Page 34-35 of the deposition Stickles blatantly lied, claiming not to own 137 SW. Madison. Tax records clearly identify that he is the owner.


