I. SUMMARY OF COMPLAINT

This complaint concerns serious professional misconduct by Attorney Kevin J. Pitts, including:

- (1) misleading a client regarding a mandatory court appearance and failing to timely correct that misinformation;
- (2) repeated failures of communication and diligence, including ignoring urgent client communications until after court had commenced;
- (3) failure to competently address evidence of fraud and identity-related misconduct directly affecting the client's liberty interests and driver's license; and
- (4) circumstances indicating divided loyalty and conflicts of interest, resulting in severe prejudice to the client's legal rights and personal liberty.

II. BACKGROUND / CONTEXT

In 2015, my father, Richard Macker, inherited substantial real estate. I was unlawfully deprived of my portion of that inheritance. By 2021, Richard collaborated with corrupt Volusia County government actors and private parties in conduct that resulted in threats to my safety, fabricated charges, false reporting to credit bureaus, unlawful felony convictions, and the unlawful suspension of my Florida driver's license.

I retained the Respondent as defense counsel with the expectation of loyal, competent, and diligent representation. Instead, Respondent failed to protect my rights, failed to act upon evidence of fraud and identity-related misconduct, and—most critically—misled me regarding a mandatory court appearance and then failed to communicate until after court had begun. This predictably resulted in the issuance of a Failure to Appear (“FTA”) warrant and a foreseeable deprivation of liberty in connection with two cases that lacked evidentiary support, arising from an ongoing pattern of harassment.

III. CHRONOLOGICAL STATEMENT OF FACTS

1. Evidence of Fraud / Identity Misuse Provided to Respondent (January 2023)

In or around January 2023, I provided Respondent with documentary evidence of identity-related fraud and financial misconduct committed in my name, including irregularities reflected in official records and related repositories. This misconduct contributed to the unlawful suspension of my Florida driver's license and other deprivations of rights.

Respondent failed to meaningfully investigate, present, or act upon this evidence through defense strategy or protective motion practice.

2. Misrepresentation Regarding Mandatory Court Appearance (April 5, 2023 – 8:30 AM)

Prior to a scheduled court proceeding set for approximately 8:30 AM on or about April 5, 2023, Respondent informed me by telephone (a few days beforehand) that I did not need to appear, stating words to the effect of: “I'll handle it—these cases lack any solid evidence.”

3. Failure to Communicate; Ignored Texts Until After Court Commenced

Respondent failed to provide timely written confirmation or corrective instruction. Respondent ignored my text messages and calls the day prior and did not respond until after court had commenced (approximately 30 minutes after the scheduled start time), depriving me of any practical ability to appear and prevent adverse consequences. The text message record supporting this allegation is attached as Physical Exhibit 1

4. Failure to Appear Warrant; Foreseeable Deprivation of Liberty

Following my nonappearance, an FTA warrant issued. Approximately fifteen (15) hours later, shortly after midnight, law enforcement entered my property, disabled a gate approximately 100 feet from the road, and forcibly entered the residence. I was assaulted at gunpoint inside my home and subsequently charged with resisting in connection with two cases that were fabricated. This sequence of events was a foreseeable consequence of Respondent's misrepresentation and abandonment of communication and mitigation responsibilities.

5. Continued Prejudice / Escalation; Failure to Provide Adequate Defense

Respondent failed to represent me competently or diligently, refused to pursue viable defenses, failed to timely file protective motions, failed to address fraud/identity issues affecting my license and liberty, and repeatedly failed to communicate. Respondent's divided loyalty and relationships with adverse private parties contributed to ongoing prejudice and deprivation of my constitutional rights and protections.

IV. APPLICABLE RULES (ALLEGED VIOLATIONS)

Based on the facts described above, I allege that Respondent violated the Rules Regulating The Florida Bar, including but not limited to:

- Rule 4-1.1 (Competence): Failure to provide competent representation, including failing to address evidence of fraud/identity misuse impacting my legal status and liberty interests.
- Rule 4-1.3 (Diligence): Failure to act with reasonable diligence and promptness to protect my interests, including failing to mitigate the consequences of misinformation and nonappearance.
- Rule 4-1.4 (Communication): Failure to keep a client reasonably informed and to promptly comply with reasonable requests for information, including ignoring communications until after a critical proceeding began.
- Rule 4-1.7 (Conflict of Interest): Representation that may have been materially limited by responsibilities to, or relationships with, third parties; circumstances indicate divided loyalty.
- Rule 4-8.4(c) (Dishonesty, Fraud, Deceit, or Misrepresentation): Misleading a client regarding a mandatory court appearance and failing to timely correct the misinformation.

- Rule 4-8.4(d) (Conduct Prejudicial to the Administration of Justice): Conduct creating foreseeable disruption and severe prejudice, including issuance of an FTA warrant and resulting deprivation of liberty.

V. REQUEST FOR INVESTIGATION

I respectfully request that The Florida Bar investigate Respondent's conduct, including:

- (1) obtaining Respondent's case file(s), communication logs, and calendar entries;
- (2) reviewing Physical Exhibit 1 text messages
- (3) reviewing Exhibit 2 (website evidence repository) for corroborating context; and
- (4) reviewing the referenced public documentary and video evidence at VolusiaTruth.com.

I further request that The Florida Bar take appropriate disciplinary action as warranted by the findings.




